## **TERMS AND CONDITIONS**

### **A. The Responsibility and Duty of the Registered Company**

- (1) The operator who carries out the service shall possess the appropriate license issued by the Government or have equivalent qualifications.
- (2) The registered company shall be responsible for ensuring the safety of the operator from any danger which can arise during operation.

### **C. Scope and Limitation**

### **D. Renewal of the Approval**
